Discussion topics for this episode include the epidemiology of DLB, the importance of making an accurate diagnosis considering that symptoms can easily be confused with other diseases, as well as advances in our understanding of the underlying biology and finally ongoing clinical research trials.

According to the Lewy Body Dementia Association, DLB affects an estimated 1.4 million individuals in the U.S. alone and is the second most common form of degenerative dementia. With the generous support of the National Institutes of Health's National Institute on Aging (NIA) in non-dilutive grant support, Cognition's Phase 2 SHIMMER trial is actively recruiting with over two thirds of sites activated and more expected to open.
